Agenda Item 1 – Call to Order, Roll Call, Agenda Distribution, Welcoming Remarks - Mr. Tony Braswell called the meeting to order at 6:30 and thanked everyone for coming out to attend our meeting. He asked speakers to fill out a speaker card and please limit their comments to two minutes. He reminded the audience that the meeting will be conducted under the Brown Act and within the guidelines of Robert's Rules of Order.

## Agenda Item 2 – Approval of May and June Minutes – Ms. Apple

Agenda Item 3 – Public Comment on Agenda Items (limited to two (2) minutes per speaker, and must fill out a speaker card) – Ms. Jeanne Rankin, from the North Hollywood Regional Public Library, gave an update on the upcoming activities at the library. Activities include summer reading club, movies, and electronic media.

Mr. Sawyer Levy, a student at Oakwood School, expressed his interest in running for the student seat next year.

Ms. Alice Hart, a resident on Riverside Drive, expressed her concerns and disappointment with AT&T. They placed a cell tower in front of her house years ago and told NCVV that they would maintain the cell tower. The tower is currently covered with graffiti and the plants surrounding the tower are dead. Ms. Hart is asking for our help to get these problems corrected and also letting us know that AT&T has not kept their word regarding the tower maintenance.

Ms. Michaela Chapman, from the American Cancer Society, gave us information on the Relay For Life Fight Against Cancer event. This event is AT&T's nationwide commitment to fight back against cancer. **Agenda Item 4 – Finance Report, Mr. Hatfield –** Mr. Hatfield is working on finalizing the June expenses and will have the final numbers for the fiscal year at our next meeting.

Agenda Item 5 – CUP Request, Valley Torah School – Presentation and Possible Motion to Approve – Ms. Ellia Thompson with CA Land Use Professionals, LLP gave a presentation on the proposed development of outdoor space to an athletic field/basketball court at Valley Torah High School.

Mr. Woersching proposed a motion and Ms. Apple seconded the motion.

**Motion:** support the conditional use permit authorizing Valley Torah High School use of lot on north side of property for an athletic field and oppose the Board of Engineers recommendation required conditions to widen, improve and make a continuous thoroughfare alley from Chandler Boulevard to Albers Street. The motion was approved by a vote of 9-0-0.

Agenda Item 6 – Bay-Delta Conversation Plan – Presentation and Possible Motion to approve – This item has been postponed until further notice.

Agenda Item 7 - Water LA - The River Project, Ms. Jessica Sanchez - Ms. Sanchez gave a presentation on Water LA. Water LA is a residence based rainwater harvesting program, conceived by The River Project and funded with a grant from the California Coastal Conservancy. They will be scheduling workshops in Studio City this fall. Workshops are open to the public. There are Core Workshops with all five workshops requiring mandatory attendance and Elective Workshops that will show you how to design and build a Water LA Best Management project for your home. Water LA can show you how to create a watershed-wise landscape that looks beautiful, saves water, reduces pollution runoff to the river, attracts birds and butterflies, and needs little maintenance; show you how to build healthy soil, remove thirsty lawn without using harmful chemicals, and grade your yard to capture the precious, free resource of rainwater. They will teach you simple steps to maintain your garden so that it functions efficiently and reaps the maximum benefits. Water from your washing machine and shower can often be reused for irrigation. Learn about systems that are available to safely collect and distribute greywater and which detergents are plant-safe, and how to install and maintain a greywater system. There will be a film series regarding this project at CBS Radford every Sunday at 6:30p.m., followed by a question and answer period.
